'Standard English' is defined in the glossary

<p>Year 2 programme of study (statutory requirements) Writing – vocabulary, grammar and punctuation Pupils should be taught to: Develop their understanding of the concepts set out in NC English Appendix 2 by:</p> <ul style="list-style-type: none"> - Learning how to use both familiar and new punctuation correctly (see English Appendix 2), including full stops, capital letters, exclamation marks, question marks, commas for lists and apostrophes for contracted forms and the possessive (singular) <p>Learn how to use:</p> <ul style="list-style-type: none"> - Sentences with different forms: statements, question, exclamation, command - Expanded noun phrases to describe and specify, e.g. the blue butterfly - Subordination (using when, if, that, or because) and co-ordination (using or, and, or but) - the grammar for year 2 in English A - some features of written Standard English <p>Use and understand the grammatical terminology in English Appendix 2 in discussing their writing</p>			<p>Notes and guidance (non-statutory) Writing – vocabulary, grammar and punctuation</p> <p>The terms for discussing language should be embedded for pupils in the course of discussing their writing with them. Their attention should be drawn to the technical terms they need to learn.</p>

<p>YEAR 3 OBJECTIVES</p> <p>Years 3-4 programme of study (statutory requirements)</p> <p>Writing – vocabulary, grammar and punctuation</p> <p>Pupils should be taught to:</p> <p>Develop their understanding of the concepts set out in English Appendix 2 by:</p> <ul style="list-style-type: none"> - Extending the range of sentences with more than one clause by using a wider range of conjunctions, e.g. when, if, because, although - Using the present perfect form of verbs in contrast to the past tense - Using conjunctions, adverbs and prepositions to express time and cause - Learning the grammar for years 3 and 4 in English Appendix 2 <p>Indicate grammatical and other features by:</p> <ul style="list-style-type: none"> - Using and punctuating direct speech <p>Use and understand the grammatical terminology in English Appendix 2 accurately and appropriately when discussing their writing and reading</p>			<p>Notes and guidance (non statutory)</p> <p>Writing – vocabulary, grammar and punctuation</p> <p>Grammar should be taught explicitly: pupils should be taught the terminology and concepts set out in NC English Appendix 2, and be able to apply them correctly to examples of real language, such as their own writing or books that they have read.</p> <p>At this stage, pupils should start to learn about some of the differences between Standard English and non-Standard English and begin to apply what they have learnt [for example, in writing dialogue for characters].</p>
